BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$33,000 from Fund 18502 to Fund 18525.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$33,000 from Fund 18525, is hereby authorized,

solely and exclusively for the purpose of providing funds for the above project.
