RESOLUTION NUMBER R- 277460

ADOPTED ON MAR 04 1991

WHEREAS, the Council of The City of San Diego on October 30, 1989 adopted Resolution No. R-274646 assigning principal tenancy at Balboa Park, including the allocation of space to the Mingei International Museum if the Hall of Champions vacated tenancy; and

WHEREAS, the Hall of Champions has elected to vacate its tenancy and move to the Federal Building; and

WHEREAS, the Museum of Photographic Arts at Balboa Park requires additional space in order to expand its educational, library and gallery offerings; and

WHEREAS, there are only two buildings in Balboa Park not currently under long term lease to other institutions that could satisfy the Museum of Photographic Arts' space needs, including the height requirement for a theater: the Federal Building and the Municipal Gymnasium; and


WHEREAS, there are no unleased or uncommitted sites in Balboa Park that can accommodate both the Mingei International Museum and the Museum of Photographic Arts; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby reconsiders Resolution No. R-274646, adopted October 30, 1989, which authorized Mingei International Museum to move into the space at Casa de Balboa to be vacated by the Hall of Champions when the Hall of Champions moves to the Federal Building.

BE IT FURTHER RESOLVED, that the Museum of Photographic Arts is authorized to expand into the space at Casa de Balboa to be vacated by the Hall of Champions when it moves into the Federal Building.

BE IT FURTHER RESOLVED, that the City Manager is directed to work with Mingei International Museum to locate an alternative site that could accommodate the museum's needs.
