That the City Manager or his designee be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Grant Deed, a copy of which is on file in the office of the City Clerk as Document No. RR-277493-7, granting to the STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION all that portion of Parcel 2, Parcel Map 10308, and portion of Lot 1, Resubdivision Villa Lot 137, Normal Heights, as more particularly described in the grant deed.
- 3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver the deeds and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
