WHEREAS, it has been determined by the Planning Department and the City Attorney that these bylaws meet the requirements of Council Policy 600-24; and

WHEREAS, on March 6, 1991, the Rules and Legislative

Committee voted to approve these bylaws as recommended by the

Planning Department and that the Normal Heights Area Planning

Committee follow the regular schedule and procedures for conducting business as a recognized community planning group as administered by the Planning Department; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the NORMAL HEIGHTS AREA PLANNING COMMITTEE be formally recognized by the approval of the bylaws, a copy of which is on file in the office of the City Clerk as Document No. RR-277499 and that the Normal Heights Area Planning Committee follow the regular schedule and procedures for conducting business as a recognized community planning group as administered by the Planning Department.
