BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$859,090.16 from Metro Pump Station No. 2, Additional Pumps, CIP 46-101.0, for the purpose of executing the Centrifugal Pump, Two Gate Valves, Cone Valve and Venturi Tube purchase contracts, from Department No. 700, Fund No. 41507, Organization No. 385, Object Account No. 4922, and Job Order No. 171643, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
