WHEREAS, the Jurisdictions Unified for Drug/Gang Enforcement (JUDGE) is a multi-jurisdictional program consisting of enforcement and support personnel from the District Attorney's Office as lead agency, Probation, the Sheriff's Office, and the Police Departments of San Diego, National City, El Cajon, Chula Vista, Oceanside and Escondido; and

WHEREAS, the goal of JUDGE is to eliminate drugs at the local manufacturing and distribution level; and

WHEREAS, the Police Department of The City of San Diego desires to participate in the JUDGE project which is to be funded through the Anti-Drug Abuse Act of 1988 and administered by the Office of Criminal Justice Planning; NOW THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and is hereby, authorized to accept from the Office of Criminal Justice Planning; the Grant Award, as set forth in the Grant Application, a copy of which is on file in the Office of the City Clerk, and he is further authorized to execute the Grant Award Agreement, including any extensions or amendments thereto.

BE IT FURTHER RESOLVED, that The City of San Diego shall provide all matching funds required for said project, including any amendment or extension thereof, under the program and the funding terms and conditions of the Office of Criminal Justice Planning, as required, if any.

BE IT FURTHER RESOLVED AND AGREED, that any liability arising out of the performance of this Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the State of California and the Office of Criminal Justice Planning disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
