BE IT RESOLVED, by the Council of The City of San Diego that the low bid of AZTEC LANDSCAPE CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF TWO (2) COMMUNITY PARKS AND TWO (2) NEIGHBORHOOD PARKS (ALLIED GARDENS COMMUNITY PARK, SAN CARLOS COMMUNITY PARK, CLAY NEIGHBORHOOD PARK AND MONTEZUMA NEIGHBORHOOD PARK), COMMUNITY PARK & RECREATION DIVISION, PARK AND RECREATION DEPARTMENT as may be required for a period of one (1) year beginning April 1, 1991 through March 31, 1992 per prices on file in the Purchasing Department, for a total estimated annual cost of \$61,008.00; terms 1% 20 days with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 15%.

BE IT FURTHER RESOLVED, that in the event the contract does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.
