BE IT RESOLVED, by the Council of The City of San Diego that the contract with OTTAWA TRUCK CORPORATION for the purchase of NINE (9) SIDE LOADER REFUSE PACKERS (Bid No. 0354/89, Item 2 - nine (9) each thirty seven (37) cubic yard side loader Rogue Model LESL-TA cab and chassis with Maxon Legal SL-10937 refuse body), authorized by Resolution No. 273097, adopted on April 3, 1989 (See Attached No. 1) is hereby rescinded.

BE IT FURTHER RESOLVED that the next low acceptable bid of T & J GARAGE, INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for Item 2 - nine (9) each thirty seven (37) cubic yard side loader (Crane Carrier Co. model LET 40A cab and chassis with Amrep side loader refuse body) at a cost of \$95,710.00 each, for a total cost of \$861,390.00; terms net 20 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$923,840.78 from Department No. 50033, Organization No. 8203, Object Account No. 6013, and Job Order No. 88079, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
