BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CEDAR RIDGE PARK DEVELOPMENT.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$168,365.00 from Park North-East Park Development Fund No. 39095, to CIP No. 29-639.0, CEDAR RIDGE PARK, and authorizing the expenditure, not to exceed \$275,170.00, from CIP No. 29-639.0, CEDAR RIDGE PARK, for the purpose of executing this contract and related costs, and

authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
