That Council Policy No. 700-1, adopted on March 15, 1962 by Resolution No. 169962, regarding Sales to Other Government Agencies be, and it is hereby amended, to allow the sale of surplus City personal property at reduced prices to governmental agencies within San Diego County with which the City has mutual aid agreements for police or fire protection, as set forth in the amended Council Policy filed in the office of the City Clerk as Document No. RR-277682.

BE IT FURTHER RESOLVED, that the City Clerk is hereby instructed to add the aforesaid to the Council Policy Manual.

It is the policy of the City Council to allow the Purchasing Agent to sell to other governmental agencies City personal property and supplies purchased at volume prices and carried as storeroom stock. Such sales may be made without prior Council approval if the amount of each said sale is less than \$5,000.

For those jurisdictions with which the City has mutual aid agreements for police or fire protection, the Purchasing Agent is also authorized to make sales of non-stock surplus City personal property at reduced prices, without prior Council approval if the amount of each said sale is less than \$5,000. Price reductions shall not exceed \$1,000 for each authorized sale.
