BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized and empowered to execute, for and on behalf of the City, an amendment to the agreement of January 22, 1990 with Black & Veatch, Engineers - Architects, for additional professional services in connection with Point Loma sedimentation basins 11 and 12, under the terms and conditions set forth in Amendment No. 1 on file in the office of the City Clerk as Document No. RR-277684, together with further amendments or modifications thereto which do not increase the project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of the project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$369,650 from the Sewer Revenue Fund (41506), CIP 46-134.0, is hereby authorized, solely and exclusively to provide funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project or parts thereof with the proceeds of tax exempt securities, if circumstances so warrant.


