

BE IT FURTHER RESOLVED, that the City's Waste Management Department is hereby authorized to utilize the services of the technical consultant selected by the County of San Diego through a competitive process to assist with the development of the City's Source Reduction and Recycling Plan required by AB 939.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$70,000 from Fund 412, Dept. 751, Object Account 4151, Job Order 7320 for consulting services related to the development of the City's Source Reduction and Recycling and Hazardous Waste Management Elements of AB 939 mandated Integrated Waste Management Plan, is hereby authorized and approved.


