WHEREAS, Pauline M. Foster and Stanley E. Foster have been active, contributing members of Congregation Beth Israel and have exhibited outstanding professional achievements, exemplary civic responsibilities, and a devotion to religious life; and

WHEREAS, Pauline has served as the only woman President of the United Jewish Federation of San Diego, as Chair of the Board of the United Way of San Diego County, as President of the President's Council of Jewish Women's Organizations of San Diego, and as area Chair of the San Diego Cancer Crusade; and

WHEREAS, Pauline currently serves on the Board of Trustees of the San Diego Museum of Contemporary Art, the Jewish Community Center, the United Jewish Federation, the San Diego Foundation for the Performing Arts, and the United Way; and

WHEREAS, Pauline has received several awards including women of Valor (Congregation Beth Israel), Torch of Liberty (Anti-Defamation League of B'nai B'rith), Women of Dedication (Salvation Army), and the Brotherhood Award (National Conference of Christians and Jews); and

WHEREAS, Stanley has been President of Ratner Corporation since 1969, is President of Foster Investment Corporation, and is Chair of the Boards of International Licensing Corporation and Hang Ten International; and

WHEREAS, Stanley currently is a director of several corporations, including Westcorp, Postal Annex, Hot Topic Inc., and Walker Scott Corporation; and

WHEREAS, Stanley serves as a member of the Board of Directors of the United Jewish Federation, as a National Trustee of the Council of Christians and Jews, and as a Director of the San Diego Chamber of Commerce; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, on the occasion and in recognition of the presentation to Pauline M. Foster and Stanley E. Foster of the Fourth and Fifth Carl Esenoff Awards for Extraordinary Community Service, does hereby declare April 21, 1991 as "PAULINE AND STANLEY FOSTER DAY" in San Diego.
