WHEREAS, the proposed amendment to the Mid-City Community Plan would redesignate two areas in the City Heights neighborhood; and

WHEREAS, Area C located at the terminus of 49th Street between Estrella Avenue and Winona Avenue, south of University Avenue, and Area D located between 37th Street and 38th Street south of Wightman Street and north of Landis Street are proposed to be redesignated from Open Space to Medium Density Residential; and

WHEREAS, the proposed amendment and the issues discussed in the Environmental Impact Report 88-0456 were considered by the Planning Commission of The City of San Diego on November 16, 1989; and

WHEREAS the Council of The City of San Diego considered issues discussed in Environmental Impact Report No. 88-0456; NOW THEREFORE,

BE IT RESOLVED, by the City Council that it be, and is hereby certified, that the Environmental Impact Report No. 88-0456, in connection with the proposed Mid-City Community Plan Amendment, has been completed in compliance with California Environmental Quality Act of 1970 (California Public Resources Code Section 21000 et seq.), as amended, and the State guidelines thereto (California Administrative Code Section 15000 et seq.),




