BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for FIRE STATION NUMBER FOUR - ASBESTOS ABATEMENT.

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$35,000.00 from C.I.P. 33-071.0, Fund 30245, for the asbestos abatement in preparation for the complete remodel of Fire Station #4, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the

Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
