BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT FAY AVENUE AND GENTER STREET.

BE IT FURTHER RESOLVED, that the expenditure of \$70,900.00 from CIP No. 62-292.0 DIF Funded, Fund 79514, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and

Comptroller upon advice from the administering department, to retain excess budgeted funds, if any, in Fund 79514.
