1. That the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an Amendment to Subdivision Improvement Agreement for MERCY MIRA MESA UNIT NO. 2, on file in the office of the City Clerk as Document No. RR-270293, to provide for the substitution of Mercy Mira Mesa 207 Associates, a California general partnership for American Newland Associates, a California general partnership, as subdivider; said Amendment to Subdivision Improvement Agreement is on file in the office of the City Clerk as Document No. RR- 277737 .



in the amount of \$2,409,510.00, is hereby released.
