BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF METRO PUMP STATION NO. 2 -- CONTROL ROOM.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$740,000.00, from Sewer Fund 41507, CIP 46-101.0, is hereby authorized solely and exclusively for providing funds for said project and related costs.
