RESOLUTION NUMBER R-277779

ADOPTED ON APRIL 23, 1991

WHEREAS, on April 23, 1991, the Council of The City of San Diego heard the request of Michael B. Galasso, President of Metropolis Investment and Development, Inc., for the City Council to clarify its understanding of the Historical Site Board's designation of the Qualitee/Carnation Dairy Building, when it upheld the Historical Site Board's designation of the exterior of the building, as Site No. 261, Grade 2, on December 11, 1990. The subject building is located at 354 Eleventh Avenue; and

WHEREAS, in reaching its decision the City Council considered the actions of the Historical Site Board on September 25, 1990, and January 30, 1991, the report of the Planning Department, materials presented prior to and at the public hearing and heard the public testimony at the hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that in upholding the Historical Site Board's designation of the Qualitee/Carnation Dairy Building, its understanding of what on the site was designated, is the same as the Historical Site

Board's understanding as reflected in the Board's actions of
September 25, 1990, and January 30, 1991.
