RESOLUTION NUMBER R- 277791

APPROVING MAP OF CANYON COUNTRY WEST UNIT NO. 2.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Hans Peter Craig, Licensed Land Surveyor, entitled "Canyon Country West Unit No. 2 being a subdivision of Lots 3 through 5, inclusive, of Canyon Country Unit No. 12, according to map thereof No. 11761, filed in the Office of the County Recorder of San Diego County April 9, 1987; and Lots 21 through 25, inclusive, and 27 and 28 of Canyon Country Unit No. 6, according to map thereof No. 12536, filed in the office of the County Recorder, January 10, 1990, together with a portion of Calle Cristobal, as dedicated to public use; in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Alvarez Meadow Court, April Leigh Terrace, Brenner Springs Way, Dennig Place, Mason Heights Lane, Paul Barwick Court, Porreca Point and Sean Taylor Lane, and said streets are hereby declared to be

public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Calle Cristobal, adjacent and contiguous to Lots 1 through 23, inclusive, and Lots 101 through 108, inclusive, all as shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the open space easements over, upon or across portions of Lots 38, 39, 49, 50, 59, 60, 71, 72 and 81 through 88, inclusive, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the sight visibility easement over, upon or across all those portions of Lots 101 through 108, inclusive, as granted and shown on the map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the landscape easement over, under, upon or across Lots 1 through 23, inclusive, 101 through 108,

inclusive, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as well as the open space, sight visibility and landscaping easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
