
RESOLUTION NUMBER R- 277800

ADOPTED ON APR 29 1991

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of street and storm drain easement deeds of EL DORADO PROPERTIES, INC., a California corporation, executed in favor of The City of San Diego, bearing notary date of February 20, 1991, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR-277800-1 and RR-277800-2, granting to said City easements for public street and storm drain purposes in Parcel 1 of Parcel Map No. 15318, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for a public street, and the same is hereby named OLD CLIFF ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
