RESOLUTION NUMBER R- 277812  
ADOPTED ON APR 29 1991

WHEREAS, on January 22, 1991, the Council of The City of San Diego approved implementation of a Residential Interior Plumbing Retrofit Program (Program); and

WHEREAS, the Metropolitan Water District (MWD) of Southern California agreed to contribute up to \$425,000 in funding for this Program in the form of a credit against its billing to the San Diego County Water Authority (CWA); and

WHEREAS, MWD's funding contribution was based upon an estimated savings of \$75.00 for each acre foot of imported water conserved through the Program; and


WHEREAS, the MWD now estimates its per acre foot savings to be \$112.00 and as a result could increase its contribution from \$425,000 to \$458,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and is hereby authorized to execute for and on behalf of the City, an agreement with MWD for receipt of funds from MWD to be used to implement the City's retrofit program as set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 277812, together with any amendments or modifications thereto which do not increase project scope or cost which the City Manager shall deem reasonably necessary from time

to time to carry out the purpose and intent of this Program and agreement.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a letter agreement with the CWA stipulating the manner in which MWD funds will be passed through to the City of San Diego as set forth in the Agreement on file in the office of the City Clerk as Document No. RR-277812-2, together with any amendments or modifications thereto which do not increase project scope or cost and which the City Manager shall deem reasonably necessary from time to time in order to carry out the purposes and intent of this Program and agreement.
