
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with JHK & Associates, for professional services necessary to inventory and evaluate safety lighting and other electrical systems in Balboa Park and provide for their upgrading, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 277852, together with any amendments or modifications thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$191,800.00 from CIP No. 21-834.0, Balboa Park Mission Bay Requirements (Capital Outlay Fund/Other, No. 302453), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project and related costs.

BE IT FURTHER RESOLVED, that the City Manager is authorized to reimburse the costs of this project with tax-exempt bonds or securities, if issued and feasible.
