WHEREAS, more than 400 female and male firefighters have gathered in San Diego for the Fourth National Conference of Fire Service Women, where they will be able to educate themselves and reinforce their commitment to the highest level of professional development as firefighters; and

WHEREAS, Women in the Fire Service have served as a network, a support system and an educational resource for women who have chosen to assume the burden of "the most dangerous profession," and in the process have become a landmark in the foundation of a fire service that is being enriched by the diversity that women firefighters bring; and

WHEREAS, National Firefighters Recognition Day occurs during the Conference on May 10, and the success of this conference will be reflected in fire departments and among firefighters throughout the United States, Canada, and England; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaims Thursday, May 9, 1991, to be "WOMEN FIREFIGHTERS RECOGNITION DAY" in San Diego, in honor of the women across the country and around the world who have chosen to join the ranks of the Fire Service.

BE IT FURTHER RESOLVED, that these women are recognized for their dedicated service and contribution to their profession, and that all residents of San Diego are encouraged to join in giving them the praise and thanks they deserve.
