BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for SIDEWALK AND CURB REPLACEMENT ON VARIOUS CITY STREETS - FY91 - (C-5).

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$200,000.00 from the Gas Tax Fund (Fund 302191), is hereby authorized solely and exclusively for providing funds for said project and related costs.
