BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for MAINTENANCE SURFACING VARIOUS CITY STREETS - GROUP "A" - FY 91, San Diego, California, on file in the Office of the City Clerk of San Diego, California on MAY 06 1991, and bearing official document No. RR-277872, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MAINTENANCE SURFACING VARIOUS CITY STREETS - GROUP "A" - FY 91.

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$4,977,568.00 from Gas Tax Fund 302191, and the expenditure not to exceed \$60,000.00 from Water Utility Operating Fund No. 41500,

and the expenditure not to exceed \$90,000.00 from Sewer Revenue Fund No. 41506, for a total expenditure not to exceed \$5,127,568.00, is hereby authorized solely and exclusively for providing funds for said project and related costs.
