ADOPTED ON MAY 07 1991

WHEREAS, the historic preservation movement influenced and continues to inspire Americans to pursue the commitment in protecting culturally and historically significant resources; and

WHEREAS, The City of San Diego has contributed significantly to the more than 800,000 entries of the National Register of Historic Places, that includes such notable historic landmarks as Balboa Park, the Villa Montezuma, the Gaslamp Quarter, the Star of India, the Padre Dam, the Long/Waterman House and the Rowing Club; and

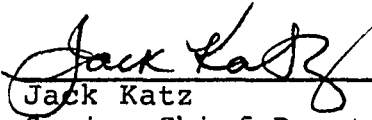
