BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF GOLDEN HILL REVITALIZATION 30TH AND FERN STREETS - PHASE 1.

BE IT FURTHER RESOLVED, that the expenditure of \$132,500.00 from CDBG Fund No. 18524, \$555,000.00 from CDBG Fund No. 18526 and \$6,817.00 from CIP 58-007, Capital Outlay Fund 30245, totaling \$694,317.00, is hereby authorized solely and exclusively

for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
