WHEREAS, this is the 20th Annual National Championship and the Mission Valley YMCA Women's Gymnastics Team has been national champion for four of those national meets; and


WHEREAS, in the tradition of the YMCA as a leading National Volunteer Organization, the Championship is organized and conducted by over 100 volunteers; and
