## RESOLUTION NUMBER R- 277906 ADOPTED ON MAY 1 3 1991

WHEREAS, the Council of The City of San Diego on March 18, 1991, adopted Ordinance No. O-17609 (New Series) entitled, "AN ORDINANCE AMENDING CHAPTER V, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTIONS 56.29 AND 56.29.1, RENUMBERING SECTION 56.54 AS SECTION 56.57 AND AMENDING THAT SECTION, AND ADDING SECTION 56.58, RELATING TO THE PROHIBITION OF ALCOHOLIC BEVERAGES AT CERTAIN CITY PARKS, BEACHES AND PUBLIC RIGHTS-OF-WAY.;" and

WHEREAS, on April 17, 1991, a referendary petition requesting the City Council to repeal or rescind Ordinance No. 0-17609 (New Series) or submit said ordinance to the registered voters of the City for their approval or rejection was filed in the office of the City Clerk as Document No.  $\frac{277996}{21}$  and

WHEREAS, the City Clerk has found the referendary petition to contain the requisite number of valid signatures and to be in proper form and has so certified, and presented this petition, with certification attached, to the City Council on May 13, 1991; and

WHEREAS, pursuant to San Diego Municipal Code sections 27.2615 and 27.2616, the Council must within ten (10) days reconsider the ordinance, and if the Council refuses to grant the petition to repeal said ordinance or fails to reconsider the ordinance within ten (10) days after presentation by the City Clerk, then the Council shall forthwith adopt a resolution of intention to submit

the matter to the people at a special election or any other election at which all the voters of the City are entitled to vote, to be held within eleven (11) months from the date the referendary petition is presented to the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the above-referenced petition is hereby granted and the City Attorney is hereby directed to prepare and docket an ordinance repealing Ordinance No. 0-17609 (New Series).
