RESOLUTION NUMBER R- 277925

WHEREAS, because of the work of this program, San Diego has achieved a nationwide reputation for the warmth with which visitors are welcomed and the high level of information services provided visitors; and

WHEREAS, all of this and the HOST Program itself were the result of the foresight, imagination and diligence of Frank Curran, then mayor of The City of San Diego, who launched the program in 1966, secured City funding for it, nurtured it through its infancy and has always taken an active interest in it through the quarter century of the Program's existence; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaims the week of May 20, 1991, to be "HOST WEEK" in

San Diego and commends the many individuals and organizations who are involved in the HOST Program for their contributions to the health of the area's visitor industry.

BE IT FURTHER RESOLVED, that May 21, 1991, be proclaimed as "FRANK CURRAN DAY" in recognition of his contributions to the HOST Program and to the welfare of The City of San Diego during his long and selfless public life.
