 DEPARTMENT: Police  
 AMOUNT: \$4,500.00  
 SUGGESTION: Mr. Trent was a Police Officer II at the time of submittal. He suggested the use of a check-off sheet (instead of a narrative report form) for the drunk-in-public arrest report. This is the remainder of his award based on first year savings of \$24,333.34 in time.

NAME(S): George Kropp, Willie Marshall and Robert Saunders  
 DEPARTMENT: General Services  
 AMOUNT: \$3,605.31  
 SUGGESTION: Messrs. Kropp, Marshall and Saunders worked in the Fabrication Shop at the time of submittal. They suggested the replacement of stamped metal spool return spring retainers on the 6100 Dumpster Packers with machine parts made from aircraft steel. This is the remainder of their award based on first year savings of \$12,017.70 in time and material.
