WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and


WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW, THEREFORE,

SUGGESTION: Mr. McAnally was an Assistant Chemist with the Metro Division at the time of submittal. He suggested the use of a six place vacuum manifold to perform analyses of total suspended solids. This is a partial award based on first year estimated savings of \$3,809.00 in time and material.

NAME(S): Thomas Abeyta  
DEPARTMENT: General Services  
AMOUNT: \$80.00  
SUGGESTION: Mr. Abeyta was a Motive Service Technician with the Equipment Division at the time of submittal. He suggested the application of non-skid strips on the sloping cement surface in front of the Rose Canyon Collection Center. This is considered to be a significant safety improvement.
