WHEREAS, the City Council of The City of San Diego has established Land Guidance as a section of the Mobility Planning Program adopted on September 11, 1989; and

WHEREAS, consultant services are necessary for the completion of the Land Guidance System; and

WHEREAS, the City Council has authorized a budget of \$90,000 for consultant services and \$15,000 for related printing, noticing and distribution costs for a total of \$105,000 for preparation of the Land Guidance System; and

WHEREAS, a Request for Proposals for the Land Guidance System was issued; and

WHEREAS, proposals were reviewed and several qualified applicants were interviewed; and


WHEREAS, the interview panel has recommended that Calthorpe Associates be granted the contract award; NOW, THEREFORE,
