
WHEREAS, in May 1990, the City entered into a ground lease with the County of San Diego (City Clerk Document No. RR-275672) and a sublease and an operating agreement with Wackenhut Corp. to allow for the construction and operation of a 200-bed misdemeanor pre-arraignment detention facility in the Otay Mesa area; and

WHEREAS, as a result of delays in the County acquiring fee title to the property, Wackenhut was unable to proceed with construction; and

WHEREAS, the acquisition of the site has now been assured by the County and it is necessary to amend the ground lease, sublease and operating agreement to reflect extended construction and operation dates; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute a first amendment to the ground lease with the County, and the City Manager is further authorized to execute first amendments to the sublease and the operating agreement with Wackenhut, in the form of those three documents on file in the office of the City Clerk as Document Nos. RR- 277955-1, RR- 277955-2 and RR- 277955-3, respectively.
