
ADOPTED ON MAY 28 1991

PARTNERSHIP, a California general partnership, executed in favor of The City of San Diego, bearing date of October 26, 1989, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 277994, granting to said City easements for public street purposes in Parcel 1 of Parcel Map No. 15226, and in Lot 25, Map No. 1390, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 47TH STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
