- 2. That the City Manager or his designee is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR- 277996, quitclaiming to ROBERT A. MASTERS and MARCIA R. GILBERT that certain easement, as more particularly described in said quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
