BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to accept, for and on behalf of said City, a Bicycle Lane Account grant from the California Department of Transportation in the amount of \$85,824 for a bikeway project.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, on behalf of said City, an agreement with the California Department of Transportation, stating that the City will install a bikeway on Miramar Road and Eastgate Mall, in accordance with the agreement on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Fiscal Year 1991, Capital Improvements Program, Annual Appropriations Budget, Capital Improvements Program, Ordinance No. O-17504, be and it is hereby modified by the addition of CIP No. 58-088.0, "Miramar Road/ Eastgate Mall Bikeway."

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to establish Capital Outlay Grant Fund No. 38506, "Miramar Road/Eastgate Mall Bikeway."

BE IT FURTHER RESOLVED; that the City Auditor and Comptroller is hereby authorized to transfer an amount not to

exceed \$85,824 from Capital Outlay Grant Fund 38506 to CIP No. 58-088.0, "Miramar Road/Eastgate Mall Bikeway."

BE IT FURTHER RESOLVED, that an expenditure of an amount not to exceed \$85,824 from CIP 58-088.0 is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
