RESOLUTION NUMBER R- 278010

ADOPTED ON MAY 28 1991

ADOPTING A COMPREHENSIVE UPDATE OF THE
MIDWAY/PACIFIC HIGHWAY CORRIDOR COMMUNITY
PLAN AND AMENDMENTS TO THE CITY OF SAN DIEGO
PROGRESS GUIDE AND GENERAL PLAN AND THE LOCAL
COASTAL PROGRAM.

WHEREAS, on August 2, 1990 and January 24, 1991 the Planning Commission of The City of San Diego held public hearings for the purpose of considering a comprehensive update of the Midway Community Plan; and

WHEREAS, this Midway/Pacific Highway Corridor Community Plan is a comprehensive revision of the original community plan adopted in 1970 and incorporates the Pacific Highway Corridor which has been removed from the Uptown plan area; and

WHEREAS, City Council Policy 600-7 provides that public hearings to consider revisions to the Progress Guide and General Plan for The City of San Diego may be scheduled concurrently with public hearings on proposed community plans in order to retain consistency between said plans and the City Council has held such concurrent public hearings; and


WHEREAS, the Council of The City of San Diego has considered all maps, exhibits and written documents contained in the file for this project on record in The City of San Diego, and has considered the oral presentations given at the public hearing;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that it hereby adopts the comprehensive update of the
Midway/Pacific Highway Corridor Community Plan and rescinds the
1970 Midway Community Plan.

BE IT FURTHER RESOLVED, that this resolution shall not
become effective within the coastal zone until such time as the
California Coastal Commission unconditionally certifies these
amendments as a Local Coastal Program amendment.

BE IT FURTHER RESOLVED, that the comprehensive update of the
Midway/Pacific Highway Corridor Community Plan shall become
effective upon adoption of an appropriate amendment of the
Progress Guide and General Plan for The City of San Diego
incorporating said plan at the next scheduled omnibus hearing.
