2. That a contingency cost amount not to exceed \$7,100.04, or 3% of apparatus cost, for changes as may be necessary during the manufacturing process is hereby authorized.

3. That the expenditure, not to exceed \$260,831.80 from Department No. 120, Object Account No. 6016, and Job Order No. 5700, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
