A RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO AUTHORIZING AN AGREEMENT
WITH THE DEPARTMENT OF FISH AND GAME FOR
THE MISSION BAY NORTHERN WILDLIFE RESERVE.

WHEREAS, the California Resources Agency has approved a \$120,000 grant from the California Tax Check-Off Fund for certain improvements at the Mission Bay Northern Wildlife Reserve; and

WHEREAS, the California Department of Fish and Game has been directed to enter into a Joint Powers Agreement with the City to effectuate the grant; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he or his representative is hereby authorized to enter into an agreement with the California Department of Fish and Game to secure grant funds in the amount of \$120,000 for the Mission Bay Northern Wildlife Reserve (aka Kendall-Frost Reserve) - Design of Observation Decks with Narrative Signs and Refencing of the Reserve, under the terms and conditions set forth in the Joint Powers Agreement, on file in the office of the City Clerk as Document No. RR-278034, together with any reasonably necessary modifications or amendments thereto which do not increase the program's scope or cost, and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this program and agreement.
