BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$61,600.00 from CIP No. 21-834.0, Balboa Park Mission Bay Requirements (Capital Outlay Fund/Other, No. 302453), is hereby authorized, solely and exclusively for the purpose of providing funds for project.

BE IT FURTHER RESOLVED, that the reimbursement of the costs associated with this project from tax exempt securities, if issued and when feasible, is hereby authorized.
