RESOLUTION NUMBER R-278047

ADOPTED ON JUNE 3, 1991

WHEREAS, Dial-A-Ride staff surveyed taxicab use by registered passengers and the survey revealed that clients enrolled as eligible for lift-equipped service, and therefore allotted a maximum of \$64 a month, were using 82% of their coupon purchases on taxicab service instead of lift-equipped service thereby receiving \$24 or 60% more a month, than other taxicab users; and

WHEREAS, nonambulatory passengers were informed by letter on May 10, 1991 of the choices and asked to return the letter to the Dial-A-Ride Program by June 1, 1991 in order to have the change effective July 1, 1991; and

WHEREAS, at the May 16, 1991 meeting of the Committee of the Whole, for purposes of hearing public testimony on the proposed FY 1992 budget, a citizen expressed concern regarding a reduction in service for nonambulatory clients; and

WHEREAS, at the Council meeting of June 3, 1991 (Item S401), Thelma Silberzweig comments were considered by Council in respect to the rate structure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that after discussion and deliberation on the matter, the City Manager be and he is hereby directed to change the Dial-A-Ride rate structure by adding the following three options:

1. Draw a coupon for \$40 to be used for a taxi or a lift; or
2. Draw a coupon for \$64 for a lift coupon only; or
