RESOLUTION NUMBER R-278050

ADOPTED ON JUN 4 1991

WHEREAS, on January 16, 1990, by Resolution No. R-274998, the Council of The City of San Diego at a public hearing adopted an amendment to the University Community Plan and the North City Local Coastal Program Land Use Plan, consisting of the addition of an Urban Design Element, previously adopted Coastal Commission suggested modifications and other miscellaneous changes to the University Community Plan; and

WHEREAS, on April 10 - 13, 1990, the California Coastal Commission at a public hearing considered an amendment to the certified Local Coastal Program to modify the North City Land Use Plan (University Community subarea) to incorporate an Urban Design Element, previously adopted Coastal Commission suggested modifications, and other miscellaneous changes to the University Community Plan which were adopted by the Council of The City of San Diego by Resolution No. R-274998; and

WHEREAS, the California Coastal Commission on April 10 - 13, 1990, rejected The City of San Diego Local Coastal Program amendment as submitted; and

WHEREAS, the California Coastal Commission certified the amendment request to the City of San Diego Local Coastal Program North City Segment with suggested modifications which if adopted by The City of San Diego would conform with the certified Land Use Plan and be adequate to carry out the provisions of the certified Land Use Plan; and


WHEREAS, the modifications suggested by the California Coastal Commission have been incorporated into the final University Community Plan; and

WHEREAS, the Council of The City of San Diego has considered the incorporation of the suggested modifications into the University Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby approves the amendment to the North City Local Coastal Program Land Use Plan which includes incorporation of the California Coastal Commission's suggested modifications into the University Community Plan.
