RESOLUTION NUMBER R-278053

ADOPTED ON JUNE 4, 1991

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on November 29, 1990, to consider the proposed Robinhood Ridge Precise Plan and accompanying amendment to the Otay Mesa Community Plan; and


WHEREAS, the Planning Commission unanimously (5-0) recommended that the City Council deny approval of both the precise plan and the community plan amendment; and

WHEREAS, the Council of The City of San Diego has considered all maps, exhibits and written documents contained in the file for the project on record in The City of San Diego, and has considered the oral presentations given at the public hearing;  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the Robinhood Ridge Precise Plan and accompanying amendment to the Otay Mesa Community Plan, a copy of which is on file in the office of the City Clerk as Document No. RR-278053.

BE IT FURTHER RESOLVED, that the Robinhood Ridge Precise Plan will be revised to include the revision recommended by Planning Report No. 91-081, dated March 1, 1991.
