RESOLUTION NUMBER R-278057

ADOPTED ON JUNE 4, 1991

WHEREAS, on June 4, 1991, the Council of The City of San Diego considered the appeal of Grace Evangelical Lutheran Church ("Church"), by Robert Dufresne, President, from the decision of the Historical Site Board in the historic designation of Grace Evangelical Lutheran Church located at 3993 Park Boulevard in San Diego. Specifically designated were the exterior of the Church, the Parsonage and Sunday School Buildings and the interior of the Church, as Site No. 265, Grade 1. The subject property is described as Block 194, Lots 1-4 and the north nine feet of Lot 5, University Heights (Parcel No. 455-660-29-10); and

WHEREAS, in reaching their decision the City Council considered the decision of the Historical Site Board, the Planning Department Report and recommendation, materials presented prior to and at the public hearing and public testimony presented at the hearing; and

WHEREAS, the City Council found that the exterior of the Church, the Parsonage and Sunday School Buildings and the interior of the Church had architectural and historical significance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal of Grace Evangelical Lutheran Church, by Robert


Dufresne, President, is denied and the decision of the Historical Site Board in designating Grace Evangelical Lutheran Church, as Site No. 265, Grade 1, is hereby affirmed.

BE IT FURTHER RESOLVED, that staff of the Planning Department shall meet with Church officials and interested members of the Church's congregation to provide information and assistance, if necessary, regarding the historical designation of the Church.

BE IT FURTHER RESOLVED, that the action of the City Council is final.
