WHEREAS, the issue was heard by the Council on June 4, 1991; and


WHEREAS, the Council of The City of San Diego considered the issues discussed in Negative Declaration No. 91-0091; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it is hereby certified that the information contained in NEGATIVE DECLARATION NO. 91-0091, in connection with the Sanyo-U.S. West Cellular project in Otay Mesa, on file in the office of the City Clerk, together with any comments received during the public review process, has been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code section 21000 et seq.), as amended, and the State guidelines thereto (California Administrative Code section 15000 et seq.), and that said report has been reviewed and considered by this Council.

BE IT FURTHER RESOLVED, that the Council finds, based upon the Initial Study and any comments received, that there is no

substantial evidence that the project will have a significant effect on the environment and therefore said Negative Declaration is hereby approved.
