

RESOLUTION NUMBER R- 278074

ADOPTED ON JUN 10 1991

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING ITS INTENTION TO AMEND ORDINANCE NUMBER O-15647 WHICH ESTABLISHED THE GASLAMP BUSINESS IMPROVEMENT DISTRICT (BID) TO PROVIDE FOR INCREASED ASSESSMENTS WITHIN THE DISTRICT.

WHEREAS, the Council of The City of San Diego approved formation of the Gaslamp Business Improvement District by Ordinance No. O-15647 on January 4, 1982; and

WHEREAS, the Gaslamp Merchants Association desires to increase the assessments to expand promotional activities within the District; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby declares its intention to increase the assessments to businesses within the Gaslamp Business Improvement District by 100 percent. The increase assessment to be charged by business category is as follows:


Category A: Nonprofit or tax exempt charitable organizations - no charge.

Category B: Businesses which generally are service and not dependent on pedestrian or automobile traffic - charge is \$100 plus \$2 per employee.

Category C: All other businesses, generally retail and dependent on pedestrian or automobile traffic - charge is \$140 plus \$4 per employee, not to exceed \$250.

BE IT FURTHER RESOLVED, that notice is hereby given that on July 2, 1991, at the hour of 2:00 p.m. in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, is fixed as the time and place when and where any and all interested persons having a desire to be heard may appear and state their views for or against the continuance of the Gaslamp Business Improvement District or the furnishing of specific types of improvements or activities within this district.
