WHEREAS, San Diego Police Officers Gaye Wagner and Andy Mills have worked to establish the Recycle Skyline and Meadowbrook Citizens Group in alleviating gang and drug activities in the Skyline community; and

WHEREAS, Officers Wagner and Mills took a Problem Oriented Policing (POP) approach in working with the Recycle Skyline/Meadowbrook Citizens Group in eliminating the presence of gang and drug trafficking activities in the Skyline neighborhood; and

WHEREAS, Officers Wagner and Mills encouraged the residents of Skyline to take back "their" neighborhood, as well as offering their assistance, making it a point not to make any decisions for them; and

WHEREAS, Officers Wagner and Mills helped Recycle Skyline/Meadowbrook Citizens Group organize a neighborhood cleanup in which over 300 people participated; and

WHEREAS, Officers Wagner and Mills persuaded the store owners at Skyline and Meadowbrook to stop selling drug paraphernalia, paint out gang graffiti, and spruce up their landscaping; and

WHEREAS, Officers Wagner and Mills are working for additional street lighting on Skyline and Meadowbrook to discourage unwanted loitering; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that San Diego Police Officers Gaye Wagner and Andy Mills be and they are hereby commended for their professionalism, ability to facilitate change through problem solving and for having a caring commitment to the community.
