

RESOLUTION NUMBER R- 278092

ADOPTED ON JUN 10 1991

WHEREAS, the City Manager did find that the condition at Mission Bay Park parking lots was an urgent matter as defined in San Diego Municipal Code section 54.0302(c) and declared that condition a nuisance within the meaning of section 54.0303(f) and consistent with the City's powers under California Public Resource Code section 30005; and

WHEREAS, the City Manager made his declaration after evaluating statistical data and reports on one hundred and sixteen (116) crime cases, forty-five (45) arrests, and thirty-five (35) citations in the last eleven (11) months in a one-fifth (1/5) mile radius from Gleason Road and West Mission Bay Drive, gang activity, two (2) stabbing deaths on June 1, 1991, and the inability of the San Diego Police Department to effectively manage the area without nighttime gating; and

WHEREAS, the City Manager took action to abate the public nuisance at Mission Bay Park parking lots by acting as follows:

1. Effective June 3, 1991, increased the level of police enforcement in the Mission Beach and Bay area;
2. Directed the police department effective June 1, 1991, to clear subject parking lots of vehicles at 10:00 p.m. and to close the lots to parking between 10:00 p.m. and 6:30 a.m.
3. Directed five (5) gates to be installed by June 11, 1991, to control ingress and egress; and

WHEREAS, the City Manager will submit an application for a


Coastal Development Permit to the California Coastal Commission;
NOW THEREFORE,

BE IT RESOLVED, that the City Council of The City of San Diego hereby supports and approves the action of the City Manager in declaring the urgent matter condition at Mission Bay Park parking lots as an public nuisance; and

BE IT FURTHER RESOLVED, that the City Council of The City of San Diego supports and approves the actions of the City Manager taken to abate the public nuisance condition at Mission Bay Park parking lots and directs him to complete all necessary implementing measures.


